Terms and Conditions for the use of Online Training Courses Produced by Radiation Safety Ireland

Terms and Conditions of use:

1. Introduction

These terms and conditions ("Terms") govern the use of the recorded online courses ("Course") provided by Radiation Safety Ireland. By accessing or using the Course, the ("User") who has purchased a Course agrees to comply with and be bound by these Terms.

2. Access and Licence

2.1 Upon payment of the applicable fee, the User is granted a limited, non-exclusive, non-transferable licence to access and use the Course solely for personal, non-commercial purposes for a specific time period.

2.2 The User may either be a user acting in their own personal capacity ("Personal User") or an employee of a company ("Company User") or other legal entity that has purchased the course on behalf of employees or contractors.

3. Intellectual Property Rights

3.1 All intellectual property rights in the Course, including but not limited to copyrights, trademarks, and trade secrets, are owned by Radiation Safety Ireland or its licensors.

3.2 The User may not modify, adapt, translate, reverse engineer, decompile, or disassemble the Course or any part thereof.

3.3 The Personal User may not share, distribute, video or digitally record, reproduce or use for commercial purposes training materials, PowerPoint presentations, course notes and recorded content produced by Radiation Safety Ireland without the prior formal agreement of Radiation Safety Ireland.

3.4 The Company User may not share, distribute, record, reproduce or use for commercial purposes training materials, PowerPoint presentations, course notes and recorded content produced by Radiation Safety Ireland without the prior formal agreement of Radiation Safety Ireland. Course summary notes only may be distributed within the Company for the client's employees or for the client's essential contractors

working on the client's site. However in order to gain formal certification by Radiation Safety Ireland the Company User must register and complete the Course online.

4. User Responsibilities

4.1 The User is responsible for providing accurate and complete information during registration and for maintaining the confidentiality of login details.

4.2 The User agrees not to use the Course for any unlawful or unauthorised purpose and to comply with all applicable laws and regulations.

4.3 Formal certification is provided by Radiation Safety Ireland once a User successfully completes a training course. An individual may not claim to have completed a training course provided by Radiation Safety Ireland unless formal certification has been provided by Radiation Safety Ireland.

4.4 Once the Course has been assigned to the user it must be completed within three months, after which the user will no longer have to access the course but will have access to download the certificate which was issued upon completion of the Course.

5. Payment and Refunds

5.1 Payment for the Course is due upon registration unless otherwise agreed in writing. All training courses must be paid for in advance either through the issuing of an official purchase order, payment on line by electronic banking, or payment through the online booking system on the website, www.radiationsafety.ie. Radiation Safety Ireland may refuse to provide a training course or to issue certification following a training course if the course fee has not been paid in full.

5.2 Costs for online training courses are per person and each individual wishing to undertake the online training must register for the online training course individually and pay the course fee online.

5.3 Refunds will only be issued if requested within 28 days of purchase and if the Course has not been accessed or used

6. Limitation of Liability

6.1 To the fullest extent permitted by law, Radiation Safety Ireland shall not be liable for any indirect, incidental, special, or consequential damages arising out of or in connection with the use or inability to use the Course.

6.2 Radiation Safety Ireland's total liability under these Terms shall not exceed the amount paid by the User for the Course.

7. Termination

7.1 Radiation Safety Ireland reserves the right to terminate or suspend access to the Course at its sole discretion without prior notice for any reason, including but not limited to breach of these Terms by the User.

8. Changes to Terms

8.1 Radiation Safety Ireland reserves the right to modify or update these Terms at any time. Changes will be posted on the Radiation Safety Ireland's website, and it is the User's responsibility to review these Terms periodically.

9. Governing Law and Jurisdiction

9.1 These Terms shall be governed by and construed in accordance with the laws of Ireland.

9.2 Any disputes arising out of or in connection with these Terms shall be subject to the exclusive jurisdiction of the courts of Ireland.

10. Data protection

10.1 We collect personal information from you, including information about your:

- Billing or purchase information
